****Update* Multiple Arrested in connection with Sexual Assault of Minor***

UPDATE CAROLINA BEACH, NC: On June 29, 2021 at 9:00 P.M., the Floyd County Sheriff's Office in Rome, GA took Patrick Austin Wise into custody. Wise is currently confined on a NoBond hold for a Fugitive from Justice warrant and is awaiting the extradition process.

CAROLINA BEACH, NC: The Carolina Beach Police Department concluded a two and a half year long criminal investigation resulting in the arrests of five people and an outstanding warrant for a sixth person whom is still wanted. The investigation began after information and evidence was located from a house party on October 31st 2018 where a 14-year-old female in attendance was assaulted by multiple attendees whom videoed and photographed the assault.
