Construction Progress:



In regard to the 30-day rule in Harbor and Marina regulations:

I extended the amount of time for the 3 anchored boats. My reason for doing so is their anchoring appeared to be stable. I did not wan to create dangerous conditions by moving them during the unusual, almost constant high winds, storms, and strong currents. Also, the large influx of anchored transit boats due to the mooring field being full almost every night.

As a rule, I make contact with all boats that anchor in CB harbor if it appears they are not transit. If they indicate they may stay for a while, I require them to fill out a CB information questionnaire form, a copy of Harbor and Marina Regulations, a copy of the pumpout log and I also inform them that we have a silty bottom that is not conducive for secure anchoring.

These are the three non-transit boats currently in our harbor:

1. Bluebird (sailboat): Owner James Wilhoite, Moved from slip to anchorage off Florida Ave 1st of March. Was told to move per the 30-day rule. Moved to anchoring north of Mooring Field 1st of April. USCG checked the vessel and inspected pumpout 30 days ago. He has called me to pumpout at Town pumpout Monday, May 23. I will be there to observe. Owner has been notified to move by June 1st. Indicated he plans to move back to Florida Ave anchorage. He is what I would classify as the only long term liveaboard currently in CB Harbor anchorage.
2. Two Down (sailboat): Owner Kevin Baird, He is owner and operator of Lower Chesapeake Bay Marine Services. Located North of Mooring Field anchorage. I met him when he first anchored. He said he was here to work on a person's boat in CB and when he finished (sometime in May) he would leave here for Beaufort, NC to work on a boat there. Just contacted him and he indicated he was leaving May 23rd or 24th. He has been to the Town pumpout while here.
3. Carissima (sailboat): Owner John Leeuwenburg, Anchored 1st of April. I asked him if he planned on staying. He used to live in CB and owns property here. He is remodeling a house he owns at 405 N 4th St. He had planned to leave sometime in May when he finished. I contacted him for update May 20, he said he may stay another week or two, but will leave for OBX by June 15, 2022.
