This spot is great on so many levels! We are a 54' power cat with a 25' and they had one spot for boats of this size at the bottom of the basin, which is such a great location. It's literally across the street from the beach, great fish tacos at Nollie's, Britt's doughnuts, a boardwalk and the amusement rides in the evenings are a special treat if you have kids. True Value and Publix are walking distance unless it's summertime hot or then first thing in the morning. This is also a great spot to wait for favorable weather and/or tides for the Cape Fear river Our slip had a pumpout station directly in front of it and the slip was not a T head, so the hose could reach both tanks, often a big deal for this cat. Larry the Dockmaster is super friendly and helpful as well as Jarrett and the local charter boat captains. Carolina Beach still feels pre-internet. I am a little over 50 years old and it feels like my childhood summers of the early 80's. I love it here. You wanna figure out what to do: walk around and talk to people. What a novel idea :) And compared to Charleston and Beaufort Docks in NC the price feels early 80s too ! It was a great stop for the this 54' power cat with a 25' beam. Thank you Carolina Beach !
