According to the contractor, the enclosed area is built with breakaway walls and is used for building entrance and access. The elevation in C2a is the elevation of this enclosed floor. The lowest equipment servicing the building is the electric meter box. All other equipment servicing the building is in the attic. There is a deck, but it is not attached to the structure.

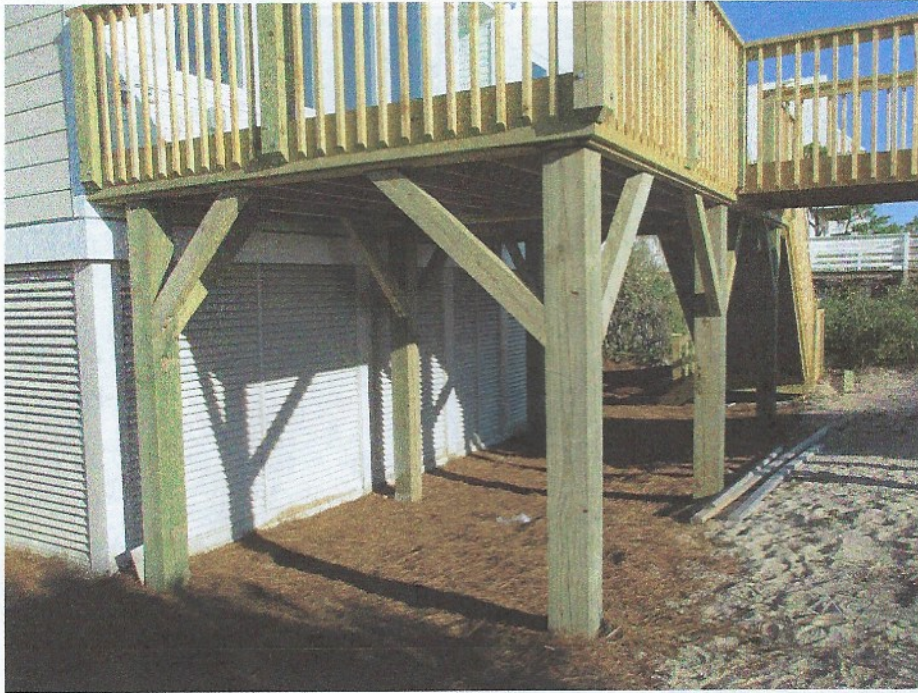
